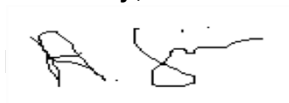

These tanker trailers are under our Orthodox rabbinic supervision and are accordingly kosher certified and normally pareve for year-round use excluding Passover. (These tankers can be approved for Passover use after a kosher upgrade wash at an approved kosher wash facility.) If any of the prior 3 loads is milk or a milk product or non-kosher wine or non-kosher grape juice, there must also be a kosher upgrade wash certificate provided from an approved kosher truck wash facility before shipping kosher pareve products again in these tankers.

This letter does not certify the kosher status of the liquid commodity being hauled. Please look for a separate kosher certificate provided by the shipper for the liquid commodity being shipped in these tankers.

This certificate is valid until December 31, 2025, and is subject to renewal at that time.
